# Summer Day Program

*A therapeutic program that's fun and exciting!*

The Summer Day Program is designed for children with special needs but is open to their typically-developing siblings as well. As a result, a variety of kids participate in fun activities together. The focus is to improve social skills in areas such as greetings/farewells, using socially appropriate language during play, recognizing personal space, sharing/turn-taking, entering social situations and engaging in play.

Each week has a different theme of exciting developmental-based activities that encourage growth in motor development, language, socialization, education, and play skills. A typical day's schedule includes:

- ◆ Opening Circle      ◆ Arts & Crafts      ◆ Music
- ◆ Games      ◆ Snack (provided by family)      ◆ Sensory Motor Activities
- ◆ Closing

The program is open to children 4 to 10 years of age and runs 9 am to 12 noon. Typically developing children will be given guidance for understanding and helping children with special needs, while also serving as peer role models. Each group will be staffed by a Casa Colina therapist and additional staff and volunteers as needed. Parents are welcome to observe and help out. **(Note: If your child is not independent with toileting you need to remain on campus.)**

## Eligibility Requirements – Please read and fill out the following:

In order to make the Summer Day Program fun and safe, your child must be able to do the following without showing aggressive or unsafe behaviors:

- ◆ Participate in group activities (i.e. able to tolerate redirection verbally or with minimal assistance)
- ◆ Stay in a group without running away; absence of flight risk
- ◆ Attend to activities for at least 5-10 minutes
- ◆ Transition from one activity to another with minimal help
