



## Homebuilder Gives \$100,000 to Casa Colina

Frank Glankler figures he had stepped over the baby gate in his kitchen -- set up to confine his family's new puppy -- at least a hundred times before the morning when he caught his foot, tripped, and tumbled, striking his head on a countertop.

The March 2004 freak accident shattered several vertebrae in his neck, leaving Glankler instantly paralyzed. But the hard-charging Ontario executive refused to accept the diagnosis from trauma center doctors who said he would never walk again following a surgery to reconstruct his neck.

"I was told my case was hopeless, that I would be a quadriplegic all my life," Glankler said. "I went to Casa Colina and five months, three weeks and a couple of days later, I walked out -- not very well, but I walked out."

Ten years after his devastating injury, Glankler returned to the non-profit Casa Colina to be on hand as his longtime friend and employer, Jimmy Previti of Rancho Cucamonga-based Frontier Communities, presented a \$100,000 donation to the world-famous rehabilitation center.

"The doctors, nurses and therapists at Casa Colina helped Frank reclaim his life," Previti said. "They gave us our friend and colleague back, and helped him return to the Frontier family, and for that we are eternally grateful."

Felice Loverso, Ph.D., president and CEO of Casa Colina, thanked Previti for the \$100,000 donation, noting that the local homebuilder has been a longtime and generous supporter of the center and its work.
